The mission of the Denver Anti-Trafficking Alliance (DATA) is to further develop a victimcentered, multidisciplinary, multi-sector response to human trafficking in the Denver metro area through collaboration; support of trauma-informed services and organizations; collaborative investigations and prosecution; education and awareness; and public policy and advocacy.

DATA includes more than 70 organizations and agencies addressing human trafficking in Denver.

DATA has an Advisory Committee, holds quarterly meetings, and operates six sector-specific subcommittees that meet regularly: Healthcare, Mental Health, Housing, Juvenile Multidisciplinary Team, Law Enforcement, and the Crime Victim Service Committee. 
2023 Report

Law Enforcement:

Data is collected from our law enforcement partners; the Denver Police Department (DPD), the Denver District Attorney's Office (DDA), Attorney General's Office (AG), the United States Attorney's Office (USAO), and the Federal Bureau of Investigation (FBI).

The DDA filed 14 new cases and resolved 13. In collaboration with the AG's office, the DDA participated in filing 7 new cases and resolved 13.


Victim Services:

Collaboration Spotlight: Clark Case

In May of 2023, Randall Clark pled guilty to first-degree assault, human trafficking, and attempt to commit sexual assault on a child. He was sentenced to 45 years in the Department of Corrections.

Over the course of several years, Clark used various methods, including manipulation, physical violence, threats, and exploitation of drug addiction to identify and control his victims for financial gain. His victims experienced complex trauma resulting in chronic health conditions and PTSD symptoms.

Supporting these victims in their recovery required immense support from service provider partners and advocates. Organizations such as, From Silenced to Saved (FSTS) met the emergency and ongoing needs of the victims throughout their recovery and the lengthy legal process. Victims were provided various support including mentorship, school assistance, substance abuse treatment and mental health services. Victim advocates and FSTS walked alongside the survivors ensuring they were prepared to share their story with the grand jury and that their voices were heard.

Law enforcement agencies, including Denver DA, Boulder DA, Denver PD, Louisville PD, and Longmont PD, and Boulder County Sheriff's office, were involved in the extensive investigation and prosecution of this trafficker. A plea was granted after conferring with Clark's victims, which allowed them to avoid testifying in front of their trafficker.

The success of this case highlights the importance of collaboration between law enforcement and service providers when seeking justice while ensuring that cases are survivor centered.
